## **Amiri Decision No. (2) of 2022**

### **Regarding**

#### **Service Fees and Fines for Connecting Establishments to the "Wiqayah" System**

We, Ammar bin Humaid Al Nuaimi, Crown Prince of the Emirate of Ajman

Having reviewed Amiri Decree No. (11) of 2011 issuing the Financial Law of the Government of Ajman and its executive regulations,

And Amiri Decree No. (1) of 2017 regarding the establishment of the Security Services Support Authority in Ajman,

And Amiri Decree No. (2) of 2018 regarding the Legislation Committee in the Emirate of Ajman,

And Amiri Decree No. (1) of 2019 regarding fees, taxes, and fines in the Emirate of Ajman,

And Amiri Decree No. (13) of 2021 concerning connecting establishments in the Emirate of Ajman to the "Wiqayah" system,

And based on the approval of the Legislation Committee,

Have issued the following Decision:

### **Article (1)**

#### **Definitions**

The following words and phrases, wherever they appear in this Decision, shall have the meanings assigned to them, unless the context requires otherwise:

The Emirate : The Emirate of Ajman.

The Authority : The Security Services Support Authority in Ajman.

The Board : The Board of Directors of the Authority.

Buildings designated for industrial, commercial, professional, and residential-commercial use in the Emirate, whether existing or under construction, and include government buildings.

Establishments:

"Wiqayah" System : The electronic early fire alarm system.

## **Article (2)**

### **Collection of Fees**

The Authority shall collect the fees specified for each of the services for connecting establishments to the "Wiqayah" system, as shown in Schedule No. (1) attached to this Decision.

## **Article (3)**

### **Recording Violations, Imposing Fines, and Their Collection**

- a. The Authority shall be responsible for recording and proving the violations stipulated in Schedule No. (2) attached to this Decision, imposing the prescribed fine for the violation, and collecting it.
- b. The violator shall be granted a period of (30) days to comply or rectify the violation. In case of non-compliance, the prescribed fine for the violation shall be collected.

## **Article (4)**

### **Entry into Force and Publication**

This Decision shall come into force from the date of its issuance and shall be published in the Official Gazette.
