**Emiri Resolution No. (22) of 2018**

**Concerning the amendment of Emiri Resolution No. (14) of  
2013**

**Regarding the registration fees in the register of suppliers,  
contractors, and consultants at the Department of Finance in  
Ajman**

We, Ammar bin Humaid Al Nuaimi, Crown Prince of the Emirate of Ajman,  
Chairman of the Executive Council.

Having reviewed the Financial Law of the Government of Ajman, issued by  
Emiri Decree No. (11) of 2011.

And Emiri Decree No. (15) of 2012 concerning the Department of Finance  
in Ajman.

And Emiri Decree No. (4) of 2014 concerning the reorganization of the  
Executive Council of the Emirate of Ajman and its amendments.

And Emiri Decree No. (2) of 2018 concerning the Legislation Committee in  
the Emirate of Ajman.

And Emiri Resolution No. (12) of 2011 issuing the Executive Regulations of  
the Financial Law of the Government of Ajman.

And Emiri Resolution No. (14) of 2013 regarding the registration fees in the  
register of suppliers, contractors, and consultants at the Department of  
Finance in the Emirate of Ajman,

And Emiri Resolution No. (8) of 2018 concerning the working system of the  
Legislation Committee in the Emirate of Ajman.

Have decided to issue the following Emiri Resolution:

**Article One**

**Amendment**

The text of Clause (1) of Article (3) of Resolution No. (14) of 2013 regarding the registration fees in the register of suppliers, contractors, and consultants at the Department of Finance shall be replaced with the following text:

**Article (3)**

1. The Department shall collect fees for the registration of the supplier, contractor, and consultant in the register according to the categories and the amount of the fee specified in the table below:

| <b>Category</b>                       | <b>Annual Registration or<br/>Renewal Fee</b> |
|---------------------------------------|-----------------------------------------------|
| Supplier - Contractor -<br>Consultant | 100 AED annually                              |

## **Article Two**

### **Publication and Entry into Force**

This Resolution shall be published in the Official Gazette of the Emirate, shall come into force from the date of its signature, and shall be circulated to all concerned authorities for its implementation and to act accordingly, each within its jurisdiction.
