Emiri Decree No. (9) of 2018

**Concerning the Service Fees of the Infrastructure
Development Sector in Ajman Municipality
and Fines for Related Violations**

**We, Ammar bin Humaid Al Nuaimi, Crown Prince of Ajman, Chairman
of the Ajman Executive Council,**

Having reviewed Emiri Decree No. (14) of 2006 regarding the reorganization of the Municipality and Planning Department in Ajman; and Emiri Decree No. (11) of 2011 issuing the Financial Law of the Government of Ajman, its executive regulations, and the systems and resolutions issued thereunder; and Emiri Decree No. (10) of 2014 regarding the establishment of the Central Administration for Legal Affairs of the Government of Ajman; and Emiri Decree No. (1) of 2015 regarding the Department of Economic Development; and Emiri Decree No. (12) of 2015 regarding the service fees of the Department of Economic Development in Ajman;

And based on the recommendations submitted to us by the Chairman of the Municipality and Planning Department in Ajman, concerning the determination of fees charged by the departments under the Infrastructure Development Sector in the Municipality and Planning Department in Ajman, and the determination of fines for related violations, and the approval of the Department of Finance in the Emirate of those recommendations;

And for the purpose of achieving the public interest...

Have decided to issue the following Emiri Decree:

Article (1)

Name of the Decree and its Entry into Force

This Decree shall be named "Emiri Decree No. (9) of 2018, concerning the Service Fees of the Infrastructure Development Sector in Ajman

Municipality and Fines for Related Violations," and it shall come into force from the first day of June 2018.

Article (2)

Definitions

For the purposes of implementing this Emiri Decree, and unless the context otherwise requires, the following words and phrases shall have the meanings assigned to each of them below:

"The State": refers to the United Arab Emirates.

"The Emirate": refers to the Emirate of Ajman.

"Municipality Department": refers to the Municipality and Planning Department in Ajman.

"Infrastructure Development Sector": refers to the Infrastructure Development Sector in the Municipality Department.

Article (3)

Service Fees

3(1) As of the effective date of this Emiri Decree:

(a) The Buildings Department - Infrastructure Development Sector shall charge the service fees specified in List No. (1) attached to this Emiri Decree in return for the services provided by the said Department to the beneficiaries of those services.

(b) The Roads and Infrastructure Department - Infrastructure Development Sector shall charge the service fees specified in List No. (2) attached to this Emiri Decree in return for the services provided by the said Department to the beneficiaries of those services.

(c) The Planning and Surveying Department - Infrastructure Development Sector shall charge the service fees specified in List No. (3) attached to this Emiri Decree in return for the services provided by the said Department to the beneficiaries of those services.

(d) The Spatial Information Systems Department - Infrastructure Development Sector shall charge the service fees specified in List No. (4)

attached to this Emiri Decree in return for the services provided by the said Department to the beneficiaries of those services.

3(2) All fees collected under paragraphs (a), (b), (c), and (d) of Article 3(1) above shall be counted as part of the annual revenues of the Municipality Department and shall be deposited into the public treasury of the Emirate.

Article (4)

Recording Violations and Imposing and Collecting Fines

4(1) As of the effective date of this Emiri Decree:

(a) The Buildings Department - Infrastructure Development Sector shall be responsible for recording and proving the violations specified in List No. (5) attached to this Emiri Decree, and shall have the right to impose and collect the prescribed fine for each of those violations.

(b) The Roads and Infrastructure Department - Infrastructure Development Sector shall be responsible for recording and proving the violations specified in List No. (6) attached to this Emiri Decree, and shall have the right to impose and collect the prescribed fine for each of those violations.

4(2) All fines collected under paragraphs (a) and (b) of Article 4(1) above shall be counted as part of the annual revenues of the Municipality Department and shall be deposited into the public treasury of the Emirate.

Article (5)

Powers of Judicial Enforcement Officers

The Chairman of the Municipality Department shall issue an administrative decision with the names of the Municipality Department inspectors who are granted the capacity of judicial enforcement officers, in accordance with the provisions of the legislation in force in the State and the Emirate. They shall have the right to record, prove, and document acts and facts that constitute a violation of the Municipality Department's regulations as specifically mentioned in List No. (5) and List No. (6) attached to this Emiri Decree.

Article (6)

Repeal of Conflicting Legislative Provisions

As of the effective date of this Emiri Decree, any text or provision in any local legislation currently in force in the Emirate that conflicts with the provisions of this Emiri Decree shall be repealed to the extent required to remove the conflict between the relevant provision and the provisions of this Emiri Decree.

Article (7)

Publication and Circulation of the Emiri Decree

This Decree shall be published in the Official Gazette of the Emirate and circulated to all concerned parties to act accordingly, each within its jurisdiction.
