

Emiri Decision No. (12) of 2013

Regarding the Service Fees of the Department of Land and Real Estate Regulation in Ajman

We, Ammar bin Humaid Al Nuaimi, Crown Prince of Ajman, Chairman of the Executive Council:

Having reviewed Emiri Decree No. (11) of 2011 issuing the Financial Law of the Government of Ajman and its executive regulations.

And Emiri Decree No. (8) of 2011 regarding the regulation of issuing local legislations in the Emirate of Ajman.

And Emiri Decree No. (12) of 2012 regarding the reorganization of the Department of Land and Real Estate Regulation in Ajman and its amendments.

And Emiri Decree No. (14) of 2012 regarding the reorganization of real estate offices in the Emirate of Ajman.

And based on the recommendations submitted to us by the Department of Finance in Ajman regarding the determination of the fees charged by the Department of Land and Real Estate Regulation in return for the services it provides to the beneficiaries of those services.

And in implementation of the authorities vested in us under Article 24 of the aforementioned Emiri Decree No. (11) of 2011.

And for the public interest,

We have decided to issue the following Emiri Decision:

Article (1)

Name of the Decision and its Enforcement

This Decision shall be named "Emiri Decision No. (12) of 2013, regarding the service fees of the Department of Land and Real Estate Regulation in Ajman," and it shall come into force from the first day of January 2014.

Article (2)

Determination of Fees

The Department of Land and Real Estate Regulation in Ajman shall charge, in return for the services it provides to the beneficiaries of its services, the fees listed in the schedule attached to this Emiri Decision.

Article (3)

Repeal of Previous Legislations

Any text or provision contained in any previous legislation that contradicts or contravenes the provisions of this Emiri Decision shall be repealed.

Article (4)

Publication of the Emiri Decision

This Emiri Decision shall be published in the Official Gazette of the Emirate and circulated to all concerned authorities to act accordingly, each within its jurisdiction.
