## **Emiri Decree No. (10) of 2025**

### **Amending Decree No. (13) of 2020 Regarding the Ownership and Disposition of Vehicle Numbers in the Emirate of Ajman**

We, Ammar bin Humaid Al Nuaimi, Crown Prince of the Emirate of Ajman,

Having reviewed Federal Law No. (14) of 2024 concerning Traffic and Motoring,

And Cabinet Resolution No. (30) of 2017 regarding Traffic and Motoring Services and Traffic Safety, and its amendments,

And Law No. (1) of 2022 concerning the Local Police in the Emirate of Ajman,

And Emiri Decree No. (11) of 2011 issuing the Financial Law of the Government of Ajman and its Executive Regulations,

And Emiri Decree No. (4) of 2014 concerning the Reorganization of the Executive Council of the Emirate of Ajman, and its amendments,

And Emiri Decree No. (1) of 2017 concerning the Establishment of the Security Services Support Authority in Ajman,

And Emiri Decree No. (2) of 2018 concerning the Legislation Committee in the Emirate of Ajman,

And Emiri Decree No. (1) of 2019 concerning Fees, Taxes, and Fines in the Emirate of Ajman,

And Emiri Decree No. (4) of 2020 concerning Service Fees and Fines applied by the Local Police in the Emirate of Ajman, and its amendments,

And Emiri Decree No. (5) of 2020 concerning Fees and Financial Consideration for Services applied by the Security Services Support Authority in Ajman,

And Emiri Decree No. (13) of 2020 regarding the Ownership and Disposition of Vehicle Numbers in the Emirate of Ajman.

And based on the approval of the Legislation Committee,

We have issued the following Decree:

## **Article (1)**

### **Substitution**

The texts of Articles (1) and (4) of the aforementioned Emiri Decree No. (13) of 2020 shall be replaced by the following texts:

#### **Article (1): Definitions**

The following words and phrases, wherever they appear in this Decree, shall have the meanings assigned to each of them, unless the context indicates otherwise:

<b>The Emirate</b>	: The Emirate of Ajman.
<b>The Crown Prince</b>	: The Crown Prince of the Emirate.
<b>The Government</b>	: The Government of the Emirate.
<b>Ajman Police</b>	: The local police in the Emirate.
<b>The Commander-in-Chief</b>	: The Commander-in-Chief of Ajman Police.
<b>First-degree relatives</b>	Father, mother, children, spouse; a spouse's relatives : are considered relatives of the other spouse to the same degree.
<b>Second-degree relatives</b>	Grandfather, grandmother, grandchildren, brother, : sister; a spouse's relatives are considered relatives of the other spouse to the same degree.
<b>Vehicle</b>	Any mechanical machine registered with the Licensing : Department that moves on the road by mechanical power or any other means.
<b>Motorcycle</b>	A vehicle with two or more wheels, equipped with an : engine, and designed for transporting people or goods.
<b>Person</b>	: A natural or legal person.
<b>Classic Vehicle</b>	Any mechanical machine registered in the Emirate that moves on the road by mechanical power or any : other means, must be at least 30 years old, and be left-hand drive, except for rare vehicles specified by Ajman Police.

#### **Article (4): Fees for Ownership and Disposition of Vehicle Numbers**

a. Ajman Police shall collect the following fees:

1. 1. The fee specified for the classification shown in Tables No. (1), (2), and (3) attached to this Decree for the one-time ownership of a vehicle number, classic vehicle number, or motorcycle number.
2. 2. A fee of (100) AED for transferring the ownership of a vehicle number, classic vehicle number, or motorcycle number from its owner to another party.
3. 3. A fee of (100) AED for transferring the possession of a vehicle number, classic vehicle number, or motorcycle number from its owner to a relative up to the second degree or to an heir in accordance with applicable legislation.

b. The owner of a vehicle number, classic vehicle number, or motorcycle number who wishes to retain it without registration is exempt from paying the vehicle number possession fees.

## **Article (2)**

### **Repeals**

Any text or provision contained in any other decree is repealed to the extent that it contradicts the provisions of this Decree.

## **Article (3)**

### **Entry into Force and Publication**

This Decree shall come into force 30 days after the date of its issuance and shall be published in the Official Gazette.
